# Minutes

Mayor Canfield called the meeting to order and Councillor Wasacase read the Prayer.

#### **CONFIRMATION OF MINUTES**

1. Moved by C. Wasacase, Seconded by R. McMillan & Carried:-

THAT the Minutes of the last Regular Meeting of Council of the City of Kenora held **Monday, June 30**, be confirmed as written and circulated.

### **DECLARATIONS OF PECUNIARY INTEREST**

Mayor Canfield then asked if any Member of Council had any Declarations of Interest with respect to any items on the Agenda. The following Declarations were made:- Councillor McDougald - Resolution No. 2.

### **DEPUTATIONS:**

#### **Emily Tacknyk-Roulston**

Ms. Tacknyk-Roulston said she was responding to a comment she had heard on the radio regarding a Councillor saying they were fed up with complaints on Main Street. She advised that Municipal politicians are the government closest to the people and you should be able to approach them. Ms. Tackyn-Roulston advised that she had been held up in traffic at the mill one day and had never seen that happen before. Ms. Tacknyk-Roulston advised that it is so much nicer to work with her than against her. Ms. Tacknyk-Roulston advised that she had a nice surprise tonight – there was no water at the swamp and she could see the culvert. She had also been sent a memo regarding the Millarship swamp. Ms. Tacknyk-Roulston extended her gratitude to Councillor McDougald. Ms. Tacknyk-Roulston said that there is no where else to go but to Council with our complaints and if they can't stand the heat – well they should not be there. Ms. Tacknyk-Roulston advised that 90% of the people do not read signs.

#### **Lydia Harlos**

Ms. Harlos gave Councillor Szajewski a copy of an article from the Thursday newspaper. She said that no one should have to be afraid and people should be able to come and get things straightened out. Ms. Harlos asked why the benches and playground equipment had been removed from the Recreation Centre. Councillor Szajewski advised that they were broken. Ms. Harlos said she does not agree that Council will not debate an issue on a deputation and there has to be communication. Mayor Canfield advised that the intent of a deputation is to listen to information which generally would be related to an

agenda item. Information will be taken under advisement. Mayor Canfield advised that people are to contact Council outside of the Council meeting as debates cannot be held at Council Meetings. Ms. Harlos mentioned telephone costs and returned a telephone to Councillor Lunny's chair.

### Paul Hoffert

Mr. Hoffert advised that he has been putting up with his situation for ten years. He said it is a water situation. Mr. Hoffert said that the street was raised about 3 feet and is sliding. Bill Preisentanz advised he will meet with Mr. Hoffert later this week to discuss this matter.

### PINECREST HOME FOR THE AGED - DEBT ISSUE

3. Moved by R. McMillan, Seconded by C. Wasacase & Carried:-

WHEREAS the District of Kenora Home for the Aged requires a debt issuance of approximately \$8.3 million in order to fund an expansion project for their Northwood Lodge and Princess Court Facilities; and

WHEREAS the District of Kenora Home for the Aged does not have legal authority to issue debt for capital expenditures, and requires any related debt to be issued through one of the contributing municipalities; and

WHEREAS the majority of the related construction will occur in the City of Dryden; and

WHEREAS the City of Kenora is aware that there will be a future debt issue requirement for the Kenora Facility within the next several years; and WHEREAS the City of Dryden has advised the City of Kenora of their interest in and approval of issuing this debt on behalf of the District of Kenora Home for the Aged; and

WHEREAS the Council of two or more of the municipalities in the territorial district may agree to authorize one of the municipalities in the district to raise the whole amount required by the issue of its debentures, in accordance with the Homes for the Aged and Rest Homes Act, Section 26 (1) (a);

NOW THEREFORE let it be resolved that the City of Kenora authorizes the City of Dryden to raise the whole amount required, up to a maximum of \$8.3 million, to fund the expansion project for the Northwood Lodge and Princess Court Facilities on behalf of the District of Kenora Home for the Aged; and further

THAT a copy of this resolution be forwarded to the District of Kenora Home for the Aged and the City of Dryden.
