of a Meeting of the Council of the City of Kenora held Monday, September 8, 2003 – City Chambers at 5:00 p.m.

WITH Mayor D. Canfield in the Chair, Councillor R. Lunny Councillor D. McDougald, Councillor R. McMillan, Councillor I. Parkes, Councillor T. Szajewski, Councillor C. Wasacase, Paulette M. Grouda, Deputy City Clerk.

Mayor Canfield called the meeting to order and Councillor Lunny read the Prayer.

CONFIRMATION OF MINUTES

1. Moved by R. McMillan, Seconded by D. McDougald & Carried:-

THAT the Minutes of the last Regular Meeting of Council of the City of Kenora held **Monday, August 25,** be confirmed as written and circulated.

DECLARATIONS OF PECUNIARY INTEREST

Mayor Canfield then asked if any Member of Council had any Declarations of Interest with respect to any items on the Agenda. The following Declarations were made:- Councillor McDougald - Resolution No. 3

DEPUTATIONS:

Carol Davis - Tourism Kenora

Ms. Davis presented the new City of Kenora Tourism Directory to Council. This Directory will be used at all the Trade Shows. Everything possible a tourist or visitor could need or want is in the Directory. Formerly tourists were given the Lake of the Woods Booklet. The project was started in April and has just been completed. Ms. Davis extended thanks to FEDNOR and LOWBIC and 21 advertisers for providing the funding for this Directory. Thanks were extended to all those who worked on the Directory, especially Ashley Haines, Student Councillor, John Edwards and Ted Weiss. There was a two year run of the Directory produced.

Emily Tacknyk-Roulston

Ms. Tacknyk-Roulston said she was glad she lives in the Country and has no close neighbours.

Ms. Tacknyk-Roulston commented that she is in favour of a study for this area if it is useful, realistic and practical for this area.

Ms. Tacknyk-Roulston asked if the study goes ahead will there be an open house and will people have a little bit of input. She also asked if it would be a practical study and said she would like a copy of the Terms of Reference.

Councillor McMillan advised that there would be public meetings and an open house.

Pearl Bannister

Ms. Bannister congratulated Council on not spraying Town properties. She said she was disappointed that Council has not passed a bylaw banning pesticides/herbicides. She advised that the chemicals cause breast cancer and asthma problems for people.

Ms. Bannister told Mayor Canfield that she hopes he does not put 2-4-D on his French fries. Mayor Canfield advised he had heard that vinegar was more toxic than Roundup.

Ms. Bannister said she is concerned with wholesale spraying more than people spraying one weed on their lawn. She told Council that they have the power to do something and have chosen not to.

Ms. Bannister said that Council is not protecting the environment in our own City boundaries and wondered how they could expand the boundaries of the City to offer protection. Ms. Bannister said the boundary expansion is simply a "Tax Grab".

Ms. Bannister asked Mayor Canfield to review the information on sodium fluoride and share it with Council.

<u>AMENDMENT TO 2003 CAPITAL – DOWNTOWN STREETSCAPE</u> <u>STUDY</u>

THAT Council of the City of Kenora appropriate an upset limit of \$27,000 from the Infrastructure/Planning Reserve to provide the necessary funding for the Downtown Streetscape Study; and further

THAT the 2003 capital budget be amended to reflect the additional funding from the Infrastructure/Planning Reserve and notification requirements as set out in Notice Bylaw No. 14-2003 be initiated; and further

THAT the Council of the City of Kenora retains the professional services of Hilderman, Thomas, Frank and Cram to undertake the Downtown Revitalization Study for an upset limit of \$99,724; and further

THAT the Clerk and the Mayor be authorized to enter into a contract for the provision of said services.

AMENDMENT TO 2003 CAPITAL FOR PUBLIC WORKS YARD RELOCATION

5. Moved by R. McMillan, Seconded by R. Lunny & Carried:-

THAT Council of the City of Kenora hereby amend the 2003 Capital Budget for the Public Works Yard Relocation by increasing the total cost estimate for the project to \$9,300,000.00 less NOHFC funding of \$1,200,000; withdrawal from the Engineering Project Reserve - \$150,000; the Engineering Reserve - \$100,000; and the Public Works Building - Keewatin - \$25,000 for a net cost of \$7,800,000; and

THAT a contribution from KMTS be approved based on their share of use of the facility as determined by a percentage of the final cost; and

THAT the net cost of \$7,800,000 less the KMTS contribution be funded by the issuance of a debenture as provided by Section 408 of the Municipal Act; and further

THAT the annual debenture payments be funded by the additional tax revenue generated from the commercial development at the former Public Works Yard on Highway 17 East so that there will be no financial impact on the municipal operating budgets.

<u>COMMUNITY RENEWABLE RESOURCES PROJECT - BRIGADE PROGRAM</u>
