## **Gerald Haines**

Mr. Haines appeared before Council with regard to the Rock Removal Contract at the new Public Works Yard. Mr. Haines advised that he had requested a Pre Blasting Inspection from the Contractor, but was advised that their conditions require an inspection within 125 metres and Mr. Haines is outside of that area. Mr. Haines advised that he is concerned as his house sits on the same rock formation as the rock being blasted. The house is built with bricks and was recently re-drywalled and repaired. Mr. Haines suggested that for everyone's protection, he would prefer a pre blasting inspection as there is a great amount of blasting to be done.

Mr. Haines was advised that this matter will be discussed at the Public Works Redevelopment Meeting tomorrow.
