

Minutes

of a Meeting of the Council of the City of Kenora held Monday, October 25, 2004 – City Chambers at 5:00 p.m.

Call to Order

Mayor Canfield called the meeting to order and Councillor Wasacase read the Prayer.

Confirmation of Minutes

1. Moved by R. McMillan, Seconded by C. Wasacase & Carried:-

THAT the Minutes of the last Regular Meeting of the Council of the City of Kenora held **Tuesday, October 12, 2004** be confirmed as written and circulated.

Declarations of Pecuniary Interest

Mayor Canfield then asked if any Member of Council had any Declarations of Pecuniary Interest with respect to any items on the Agenda. Councillor Compton made a Declaration of Interest at the Closed Session held October 19, 2004 regarding an identifiable individual.

DEPUTATIONS:

Pat Barnard - Hwy. 17 East Construction

Pat Barnard advised Council that she and her husband Moe Barnard own and operate Pine Portage Service on Highway 17 East. Mrs. Barnard presented a Petition of over 80 names that has been collected at Pine Portage Service that requests the City to resume the construction on Highway 17 East as early as possible in the spring of 2005 in order for this construction to be completed as soon as possible.

Don Kinger - Council Meetings

Mr. Kinger expressed concern regarding procedures of Council at meetings and he referred to Procedural By-law #33-2004. Mr. Kinger believes the by-law is not being followed with respect to: deputations, debate issues, quorums, and the way in which Pecuniary Interests are declared by Members. In closing he recommended that Council meeting times are not public-friendly being that they're held at 5:00 p.m. He suggested Council consider changing these meeting times to 7:00 p.m. to allow more members of the public to attend.

Approval of Accounts

2. Moved by R. McMillan, Seconded by T. Szajewski & Carried:-

THAT the Reports dated **October 14, 2004** of the Finance and Administration Committee, submitting for approval and authorization for payment, invoices, accounts and payroll summaries, including transfers to



Boards and Commissions for municipal and utility listings, attached hereto, totalling **\$464,072.02** be hereby authorized for approval.

Local Health Integration Networks

3. Moved by R. McMillan, Seconded by T. Szajewski & Carried:-

WHEREAS the present government is addressing the delivery of health care in the province and this direction is consistent with the priorities of this government (health care and education); and;

WHEREAS in keeping with this direction, the Ministry of Health and Long-Term Care is underway with a plan to create an integrated health care system that is patient-centred and responsive to local health care needs; and

WHEREAS Health Care Partners in the province, including municipalities, have been provided with information from the Ministry which outlines the geographic boundaries for the Local Health Integration Networks (LHINs), the methodology for their selection, together with a governance model; and

WHEREAS fourteen (14) geographic boundaries have been created in the province with the North West division comprised of the three districts of Kenora, Rainy River and Thunder Bay; and

WHEREAS the proposed geographic boundary for the North West division does not necessarily reflect the local areas where people would naturally seek health care being that many patients in the Kenora District travel to Winnipeg, Manitoba for a variety of health care needs, treatments, assessments and specialists; and

WHEREAS should the size of this large geographic boundary dictate the size of the proposed Board to govern the LHIN in the North West division, it will be an unmanageable size making it both difficult for community representatives to attend meetings as well as being particularly expensive at the same time;

NOW THEREFORE BE IT RESOLVED THAT the Council of the City of Kenora hereby petitions the Honourable George Smitherman, Minister of Health and Long-Term Care to re-examine the geographic division of the LHIN for the North West and to consider removing the Districts of Rainy River and Thunder Bay from the boundary as the size as established is logistically far too vast for one division, and is not practical nor fair for those patients having to travel long distances across the division to access a health care community; and

THAT by re-defining and limiting the North West boundary, the make-up of the Board for this purpose will be more viable and more cost-effective, not only for its representing Members but for the residents of this part of the province that they will serve; and further

THAT a copy of this resolution be circulated to all municipalities in the Kenora District for their support and endorsement, as well as forwarding a copy to the Honourable Dalton McGuinty, Premier of Ontario, Howard Hampton, M.P.P., the Northwestern Health Unit, the Northwestern Ontario Municipal Association (NOMA), the Thunder Bay Municipal League and the Rainy River Municipal Association.
