Council Request for Information & Overtime

Councillor Compton raised the issue of access to information and employee overtime in the amount of \$588,000 for the year 2003 and the fact that it equates to \$1.00 for every \$30.00 of taxpayers' money in addition to other costs associated with overtime. Councillor Compton also raised the issue of 30% increase in Finance and Administration Staff since amalgamation and a lot of money for computers.

During budget deliberations, Council has been provided with a report regarding 2003 overtime and proposed 2004 overtime. Councillor Compton is requesting a breakdown of the overtime for Finance & Administration, Kenora Police Service, Planning, and Operations (11 Items from Roads to Solid Waste Supervisor).

Bill Preisentanz referred to his memo to Council dated March 15, 2004 regarding recommendations concerning procedures for special requests for information and overtime. Special requests for information outside of the City's normal reporting requirements, which require the allocation of additional resources, should have the support of Council.

With respect to the current overtime policy, it iwas recommended that Council take the following steps with respect to controlling overtime within City Departments for 2004:

- a) that the HR Department provide Council with the 2003 annual overtime report by April 30, 2004 including ways and means of controlling and minimizing overtime
- b) that final recommendations to control and minimize overtime for all City Departments be approved by May 15, 2004
- c) that a moratorium be placed on 2004 overtime for Municipal Departments except for emergency situations as determined by the Department Head and reported monthly to the CAO
- d) that the moratorium commence immediately and remain in effect until recommendations are ratified by May 15, 2004
- e) that the Kenora Police Services Board be requested to identify
