Take Notice that as required under Notice By-law No. 14-2003, Council intends to adopt the following by-laws at its February 21 meeting:

- (1)** To adopt the following revised Cemetery Tour rates for the Lake of the Woods Cemetery, subject to Ministry approval:-

Regular Friday Tours (July & August) - \$3.00 per person
Friday Night Lantern Tours (June, July & August) - \$5.00 per person
Tours on Request (during regular working hours) - \$50.00
Tours on Request (evenings or Saturdays) - \$100.00
School Tours – No charge

- (2)** To amend Schedule “D” of the Tariff of Fees By-law by adding “Copy of Comprehensive Zoning By-law No. 160-2004 \$55.00 + GST” and Copy of City of Kenora Official Plan \$50.00 + GST.”

- (3)** Two readings will be given to a by-law to amend the City’s Taxi By-law to provide for a rate increase, effective March 15, 2005.

- (4)** To officially name that portion of highway running east and west between Veterans Drive and Mellick Avenue as “14th Street North”.
