## **Call to Order**

A/Mayor Parkes called the meeting to order and Councillor McMillan read the Prayer.

## **Confirmation of Minutes**

1. Moved by L. Compton, Seconded by R. McMillan & Carried:-

THAT the Minutes of the last Regular Meeting of the Council of the City of Kenora held **Monday, February 21, 2005** be confirmed as written and circulated.

## **Declarations of Pecuniary Interest**

A/Mayor Parkes then asked if any Member of Council had any Declarations of Pecuniary Interest with respect to any items on the Agenda. There were none declared.

#### **PRESENTATION:**

A/Mayor Parkes presented Fire Chief Warren Brinkman with his 20 Year Medal for Exemplary Service from the Governor General of Canada. A/Mayor Parkes congratulated and thanked him for his dedicated service over the years.

#### **DEPUTATIONS:**

#### **Emily Tacknyk-Roulston**

Ms Tacknyk-Roulston advised that she is still waiting for a response to her question asked earlier regarding a comment by Mayor Canfield about increasing taxes and a higher expectation of the taxpayer. She explained she has been waiting for the Mayor's return to answer this question, and she'd like a response from him as well as from Members of Council at the next meeting.

#### **Helene Dubenski**

On behalf of the Ukrainian Women's Association Mrs. Dubenski requested Council's consideration for a Ukrainian Monument to be erected on the Harbourfront. The purpose of the monument is a dedication to the early Ukrainian settlers who arrived in the Kenora District and made this area their home. Mrs. Dubenski is seeking an early reply to this request, and A/Mayor Parkes advised her request will be forwarded to Committee for review.

## Carmen Marginet & Walter Keejick

Ms Marginet advised that she and Walter Keejick are Gambling Councillors and she circulated various information to Members of Council on Gambling



Prevention Month. She emphasized that gambling is an emerging social issue and requested that the month of March be proclaimed as Gambling Prevention Month in the City of Kenora. Ms Marginet indicated that various events will be taking place in the community during the month of March. Mr. Keejick advised that Treaty 3 has developed programs to alleviate the negative affects of gambling that includes prevention and awareness.

#### Cory Gabryluk

Mr. Gabryluk advised Council he is not in favour of the re-zoning of 314 First Avenue South and explained that he is not against the business but is primarily dissatisfied on the whole approval process. He again expressed concern on not receiving a letter from the City advising of the proposed rezoning and that he inadvertently saw the advertisement in the Miner and News. Mr. Gabryluk cannot understand why renovations to the residence could proceed to accommodate a business without proper approvals being in place. He further cited the change in zoning to be an invasion of his privacy with increased vehicular/pedestrian traffic and added congestion in the area including concern on inadequate parking.

- 2. Under Discharge of Firearms By-law Number 41-2001 to allow 105 mm Howitzer blank rounds of artillery; and further

THAT National Defence be required to publicly advertise these exemptions in a local newspaper, at least 10 days in advance of the date of its demonstration.

THAT all the lands contained within the boundaries of Lots 2,3,4,5,6 and 7, on Registered Plan of Subdivision M.248, in the City of Kenora, formerly the Town of Kenora, in the District of Kenora are hereby deemed not to be lands described in accordance with a registered plan of subdivision for the purposes of Section 50(4) of the Planning Act, RSO 1990;
- 2. THAT the Mayor and Clerk be and are hereby authorized to execute any and all documents required to complete this transaction; and further
- 3. THAT the following Section 118 Land Titles Act restrictive covenant be registered against the titles of Lots 1, 2, 3, 4, 5, 6, 7 on Plan M.248 and Parts 1 and 2 on Plan 23R-10835, in the Register for the District of Kenora that no transfer of the lands shall be made or charge created unless the written consent of The Corporation of the City of Kenora is obtained. The consent of The Corporation of the City of Kenora is not required in instances where all properties affected by the restriction are transferred or charged together to the same party. These covenants shall be binding upon and enure to the benefit of the respective heirs, administrators, successors and assigns of the parties."

#### **Zoning Amendment - Spicer**
