Of a Meeting of the Council of the City of Kenora Monday, June 27, 2005 – City Council Chambers 5:00 p.m.

Call to Order

Mayor Canfield called the meeting to order and Councillor Parkes read the Prayer.

Public Information NOTICES as per By-law Number 14-2003 Mayor Canfield then read the following notices:-

As required under Notice By-law No. 14-2003, Council hereby advises the public of its intention to adopt the following by-laws at tonight's meeting:-

- (1) to authorize an appropriation from the City Hall Reserve in the amount of \$12,051.19 for the purchase of three replacement air conditioning units for City Hall;
- (2) to authorize an appropriation from the Computer Reserve Fund in the amount of \$10,361.00 for the purchase of the Trend Micro anti-virus software;
- (3) to authorize an appropriation from the Contingency Reserve in the amount of \$14,000.00 for funding to the Triple P.L.A.Y. Program.

Confirmation of Minutes

1. Moved by R. McMillan, Seconded by T. Szajewski & Carried:-

THAT the Minutes of the last Regular Meeting of the Council of the City of Kenora held **Tuesday**, **June 13**, **2005** be confirmed as written and circulated.

Declarations of Pecuniary Interest

Mayor Canfield then asked if any Member of Council had any Declarations of Pecuniary Interest with respect to any items on the Agenda. There were none declared.

DEPUTATION:

Scott Compton

Scott Compton appeared before Council regarding a Code of Conduct Complaint. Mr. Compton advised Council that the mechanism the City has in place for dealing with official complaints made against Employees who breach the City's Employee Code of Ethics does not work. Mr. Compton advised that it was almost a year since he had filed a Breach of Code of Ethics Complaint with Mr. Preisentanz against a City Employee. During the course of administrating an Application for Consent to sever a lot from his property on the Beach Road, the City Employee in question breached Code of Ehtics Policy No. HR-2-1, 2.04 A Dealing with Integrity, Item No. 4 "to knowingly breach the law in the performance of his or her duties or to request others to



do so", Integrity No. 5, "To intentionally falsify any of the City's records", and Policy No. HR-2-1, 2-04B Dealing with Impartiality "Every municipal employee must perform his or her duties in an impartial manner".

Mr. Compton advised that he had sent 6 requests in to Bill Preisentanz over the last 11 ½ months and his complaint has still not been resolved. Mr. Compton advised that Mr. Warren Spencer, former Operations Manager and Mr. John Fregeau, the lawyer who handled his consent application have yet to be interviewed by Mr. Randy Seller, a local lawyer retained to investigate his complaint.

Mr. Compton advised that he not only has a problem with the length of time this investigation is taking but also with the City's choice of Mr. Seller as investigator. Mr. Compton advised that under most circumstances Mr. Bruce Ormiston would have been called upon to advise as a suitable investigator. Mr. Ormiston did not involve himself because the firm Shewchuk, MacDonell, Ormiston, Richardt and Fregeau acts for him and his wife and Mr. Ormiston would have been in a position of Conflict. Mr. Randy Seller, the City's choice for investigator, is a partner with the firm Hook, Seller and Lundin who act for the employee in question. Mr. Compton questioned how Mr. Ormiston would be in a conflict and Mr. Seller not.

Mr. Compton advised that Mr. Seller has had since November 2004 to bring this complaint to resolution and has not done so. Mr. Compton advised that this deputation is his last recourse before he seeks an Order of Mandamus, a court order, which forces public officials to fulfill the duties of their office. Mr. Compton asked Council to choose an unbiased party from outside Kenora to investigate and resolve this matter in a timely fashion.

Triple P.L.A.Y. Funding throught Contingency Reserves

2005 Capping Options – Implementation Tools

7. Moved by R. McMillan, Seconded by C. Wasacase & Carried:-

THAT Council approve the implementation of the following tools for the 2005 taxation year:

- Annualized Tax Limit of 10% for each of the commercial, industrial and multi-residential property classes.
- Prior Year's CVA Tax Limit of 5% for each of the commercial, industrial and multi-residential property classes.
- CVA Tax Threshold for Protected Properties related to increases in the amount of \$250 for each of the commercial, industrial and multiresidential property classes.
- CVA Tax Threshold for Clawed Back Properties related to decreases in the amount of \$250 for the commercial and industrial property classes; and further

THAT the appropriate By-law be approved for this purpose.

New Construction & New to Class Properties

NOMA Per Capita Levy – Forest Industry

9. Moved by R. McMillan, Seconded by C. Wasacase & Carried:-

Whereas the Forest Industry in Ontario is in crisis; and



Whereas each and every community in Northwestern Ontario will be negatively impacted if the crisis is not averted; and

Whereas the Minister's Council on Forest Sector Competitiveness was established to provide a set of recommendations that will act as a road map for the Government of Ontario and the Ministry of Natural Resources in particular, for the development of strategies to address the current challenges both immediately and over the long term; and

Whereas the production of the report was a collaborative effort between individuals representing the forest industry, labour, First Nations, the environmental community, municipalities, and also included independent experts; and

Whereas the formation of the Minister's Council is an explicit recognition on the part of the Ontario Government that change is needed to ensure the viability of the industry, and the report identifies the root causes of the industry's decline in Ontario and recommends a multi-pronged strategy to assist the province's forestry sector in regaining its competitive footing; and

Whereas NOMA has taken the lead in developing a strategy to convince the Government of Ontario to implement the Council's report; and

Whereas a key component of that strategy is the hiring of a major lobbying firm to develop and implement a government relations strategy; and

Whereas the Ontario Forest Industry Association and the Ontario Lumber Manufacturers Agreement have tentatively agreed to each pay one third of the cost of the contract; and

Whereas NOMA has agreed to raise up to \$83,000 as their share of the contract; and

Whereas, the Northwestern Ontario Associated Chambers of Commerce have agreed to contribute \$5,000 and the Northwestern Ontario Development Network \$1,500; and

Whereas the NOMA Board of Directors at their June 10, 2005 meeting adopted a motion that included the following clause:-

"That NOMA establish a special per capita levy of \$0.40 from (each of) its' Member Municipalities (50% immediately and 50% when required)"

Now Therefore be it resolved that the Municipality of the City of Kenora authorizes the expenditure of \$0.40 cents per capita in the amount indicated in the attached letter from the NOMA President.

B.I.A. Levy
