Finance & Administration

- Approval of Accounts Listings.
- Approval will be given for a public consultation process as part of the 2006 budget deliberations, together with the drafting of a policy for this purpose.
- Council will adopt a by-law to amend the 2005 Capital Budget to assist with the purchase of a police vehicle.

- COUNCIL AGENI
 - Approval will be given to proceed with the development of a staff parking policy based on cost recovery, together with considering alternate parking options for staff currently utilizing the Parkade facility.
 - Council will approve maintaining its insurance coverage for 2006 with Frank Cowan Insurance Company on a month to month basis, together with requesting proposals for insurance coverage for the balance of the year.
 - Council will endorse a resolution with respect to N.O.M.A's energy policy.
 - A by-law will be adopted authorizing an agreement with Great West Life Assurance Company.
 - A by-law will be adopted authorizing an agreement with the Canada Employment Insurance Commission.
 - Approval will be given to provide an exemption under the Traffic By-law with respect to vehicles displaying an Ontario Veterans' license plate.

Community Services

• Council will approve the holding of the 2006 Sno-X Races at the Kenora Recreation Centre, and the entering into of an agreement for this purpose.

Operations

- Council will amend the Comprehensive Traffic By-law with respect to "no parking/tow away zones and stop signs at intersections."
- Council will make a recommendation with respect to access along 19th Avenue North.
- Council will approve a "Vehicle Operation Policy."
- A by-law will be adopted to authorize the installation and use of extension cords over or upon public walkways.
- Approval will be given to adjust the rates of contracted services for the haulage of both solid waste and recycling materials.
- A by-law will be adopted to authorize the entering into of an agreement for funding for the Water Treatment Plant Upgrade.

Property & Planning

• Authorization will be given to enter into a Service Delivery Agreement with the Township of Sioux Narrows-Nestor Falls.



- Approval will be given to forward the third and fourth quarter payments for 2005 to LOWBIC.
- Approval will be given to adopt various by-laws with respect to the transfer of certain property from Weyerhaeuser and Hydro One, together with the official naming of TJ Way.
- Council will declare certain property as surplus to the needs of the municipality located south of St. Clair Street and in between 8th and 9th Streets (Keewatin neighbourhood), and will commence the process of offering the property to abutting property owners as well as the legal process under the Municipal Act.
