#### 1. Heritage Committee - New member

In order to fill a vacancy, the Heritage Committee determined the best approach would be to have Council appoint one of the applicants that had originally expressed interest in committee membership. At the February 27th meeting of the Heritage Committee, a resolution was passed that Murray McDonald be appointed by the City as a representative to fill the vacancy left by Shalene Rawluck.

#### **RECOMMENDATION:**

THAT Council accepts the nomination by the Heritage Committee that Murray Donald be named as a the Community-at-large member to fill the vacancy left by the resignation of Shalene Rawluck.

#### 2. Economic Development Officer - Report

Jennifer presented the following highlights of her report: **Common Ground Workshop** Workshop will be held on March 9/10 at the Super 8. An orientation session and tour will be held on March 8 at 4:30 p.m. to allow workshop participants to become more familiar with the lands. Participants will include City of Kenora Mayor, Council, staff and volunteers; Representatives of Dalles, Rat Portage and Washagamis Bay Bands, the three First Nations who originally formed the Rat Portage Band and representatives of Grand Council Treaty #3. Abitibi will have two representatives participating in the workshop. The workshop is expected to develop a vision and work plan for implementation of the vision of the lands. **At the Crossroads:** Forum #2 will be held during the week of April 24. Rick Beaton from Enterprise Cape Breton has been invited as a

panel speaker. Mr. Beaton is one of the country's best economic development practitioners -Jennifer will try and re-schedule the forum. **Economic Development Committee**: 1. Economic Development Committee will meet March 17 to discuss the development of an Economic Development Plan including the following elements: a. Investment Prospecting Strategy b. First Nations Partnership Development c. Tourism and Winter Tourism Strategies d. Adaptive Re-use and Marketing of the Abitibi site. The Committee will develop a workplan which will become Jennifer's mandate. Branding: The Branding project proposals are due March 10. The Branding project committee will review proposals on March 15. Several firms, including locals have indicated an interest in the project to date. Municipal Cultural Planning Partnership Forum Kenora will be the host site for a regional Municipal Cultural Planning Partnership Forum on Wednesday, April 5 2006. Keynote speaker will be former Winnipeg Mayor Glenn Murray. He will speak about creating culturally dynamic urban centres. He will discuss the importance of maintaining the 3 P's of municipal government (pipes, potholes and police), and talk about the essential need for municipalities to also make room in their planning and budgeting for advancing the arts, culture, and heritage aspects of a community. workshops will include Downtown Revitalization and Cultural Tourism.

#### 3. LOWBIC - Special Events Program Extension

Bill Preisentanz commented on LOWBIC's agreement to the contract extending the special events program and thanked Ian for bringing the issue forward to the LOWBIC Board. He commented on the importance of the program, citing the recent Snow X event as an example.

#### **RECOMMENDATION:**

That Council of the City of Kenora hereby authorize funding to LOWBIC for Special Events and Community Social Service programs as outlined in 2005 budget based on actual costs incurred for those program costs to May 31, 2006.

## Sale of Municipal Property - Portion of Road Allowance, Dufresne Island
