Take Notice that as required under Notice By-law No. 14-2003, Council intends to adopt the following at its August 13, 2007 meeting:

- 1. An amendment to the 2007 Capital Budget to authorize reallocation of funds from the City's server replacement program for implementation of a virtualized server environment with centralized storage area networks, including a reduction of the related budget allocation from \$97,000 to \$79,775;
- 2. To redirect capital funds remaining from Coney Boardwalk Capital project for washroom repairs at Coney Beach;
 - 3. To Increase Daily Rate Fees for the Castle of Learning & Discovery Children's Centre effective September 1, 2007;
 - 4. To redirect capital funds remaining from purchase of Park's mower to capital purchase of Ice Re-surfacer;
 - 5. An Amendment to Tariff of Fees By-Law #100-2003 Schedule "B" Recreation Rates effective September 1, 2007;
- 6. To amend By-law #127-2002 Transit Service Agreement Schedule "G" to amend Bus Pass Rates;

7. To amend the 2007 Capital Budget to authorize an appropriation from the Downloaded Solid Waste Reserve for the purchase of software for the Solid Waste Transfer Station Scale program.
