WHEREAS under the Constitution of Canada, the Provincial Government has the authority and responsibility for Municipal Issues, including the funding and financing of Municipal infrastructure programs;

NOW THEREFORE BE IT RESOLVED THAT the Municipality of Kenora requests that the Government of the Province of Ontario commit 1/8th of the current 8% Provincial Sales Tax to Municipalities to fund Municipal Infrastructure Programs; and further

Funding - Infrastructure

12B Moved by D. McCann, Seconded by W. Cuthbert & Carried:-

WHEREAS Municipalities in the Province of Ontario continue to have problems funding existing and new infrastructure; and

WHEREAS Canadian municipalities' share of infrastructure costs has doubled over the last 50 years, while the federal government's has shrunk to less than half; and

WHEREAS the Federation of Canadian Municipalities has recently reported that the current municipal infrastructure deficit has reached \$123 billion nationally and continues to grow; and

WHEREAS the Ontario Municipal Water Association has joined the campaign for fair funding for infrastructure to address the infrastructure deficit amounting to billions of dollars; and

WHEREAS the federal government chose to use the surplus to reduce Canadians' taxes through reductions to the GST, income tax and corporate tax; and

WHEREAS it is important to reiterate with the Federal Government the importance of proper funding for infrastructure from all levels of government;

NOW THEREFORE BE IT RESOLVED THAT the City of Kenora hereby requests the federal government, in conjunction with other Canadian municipalities, to use its \$11.6 billion surplus and projected \$65 billion surplus cumulative to 2013 to help municipal infrastructure projects; and further

THAT a copy of this resolution be forwarded Prime Minister Harper and Finance Minister Flaherty, as well as the Ontario Municipal Water Association.
