Call to Order

Sale of KMTS Assets

WHEREAS the Council of the Corporation of the City of Kenora has reached an Agreement with Bell Aliant for the sale of Kenora Municipal Telephone System (KMTS) and its assets including the lands described on the attached property list, as provided for in the attached Agreement; and

WHEREAS the Corporation of the City of Kenora has identified KMTS property as surplus land and assets and has reached an Agreement with Bell Aliant to sell the said KMTS lands and assets;

NOW THEREFORE the Corporation of the City of Kenora enacts as follows:

- 1. THAT the Corporation of the City of Kenora hereby declares the land and assets described in the attached Agreement as surplus lands and assets.
- 2. THAT the Corporation of the City of Kenora shall sell to Bell Aliant the lands and assets of KMTS for the sum of \$27,000,000.00
- 3. THAT the Mayor and the Clerk or Deputy Clerk be and they are hereby empowered to execute the attached Agreement and all documents necessary to complete the transaction.
- 4. THAT a By-Law be given three readings to effect this transaction.
