Dr. A. Craig – Kenora Catholic District School Board

Dr. Craig circulated copies of his speaking notes to Members of Council and the Clerk with respect to the amendment to the Site Plan Control Agreement for St. Thomas Aquinas High School Property. Dr. Craig's deputation referred to the capital expansion of the Multi-Skills Training Centre and the Grade 7 and 8 addition. He spoke in support of this amendment, noting the Board has engaged in positive discussions with the neighbourhood and City officials.
