C. STANDING COMMITTEE DEPUTATIONS: Suzanne Broten was in attendance, representing West Kenora Housing. The agency is requesting a variance to the fence by-law in order to erect a 6 foot high, wrought iron look fence, in order to address some security issues on the Gardner Block property. She explained that the residents are concerned with an ongoing vagrancy problem and active begging. The fence will be located approximately 10 feet north of the sidewalk, with two gates which will be accessible only to residents/maintenance personnel. The budget is from a reserve fund and the expenditure requires the approval of the Kenora District Services Board.

1) Application for variance to Fence By-law No. 94-2006

The Committee discussed the need for security and the attractive fencing as a solution.

5) Interpretation of Boundaries – Zoning By-law and Official Plan

Councillor Cuthbert indicated that this issue had been brought forward as and issue respecting use of the Matheson Street Dock for commercial purposes. She reminded the Committee that Council amended the zoning by-law in 2005, to remove the requirement for businesses to provide parking in the Harbourtown Centre.

The Committee discussed the requirement for private property owners to ensure proper signage if they do not want people, other than their own customers, to park in their parking lots. Staff was directed to ensure the mapping errors are rectified by including <u>all</u> water lots in the Harbourtown Centre.

RECOMMENDATION:

That Schedule "A" of the City of Kenora Official Plan be revised so that the Harbourtown Centre land use designation boundary match the General Commercial – GC zoning designation boundary.
