RE: SCREENED WINTER SAND TENDER 2009

BACKGROUND:

The City of Kenora tenders annually for the supply, delivery and stockpiling of M.T.O. screened winter sand. Individual tenders for sand and salt closed on June 18, 2009. The salt is delivered to the contractor for mixing at a ratio of 1 part salt to 25 parts sand prior to being delivered to the Operations Centre yard at Fourteenth Street North.

Treated Winter Sand - 11,000 tonnes

The tender for 11,000 tonnes of treated material for the 2009/2010 winter season received the following two quotes (tax included):

Hugh Munro Construction \$20.99 per tonne Joe Neniska & Sons Ltd. \$15.80 per tonne

Prior to award of contract, the proposed material will be subjected to a sieve analysis testing.

Salt - 500 tonnes

Tendering for the supply of 500 tonnes of salt was by invitation and received the following two quotes (tax extra):

Sifto Canada Corp. \$114.93 per tonne NSC Minerals \$109.34 per tonne

Comparison: 2008 tender prices:

Sand 7,500 tonnes Joe Neniska & Sons \$15.80 per tonne (tax included) Salt 500 tonnes Sifto Canada \$108.02 per tonne (tax extra)

Winter sand is charged out under an Inventory account number on a per tonne basis as it is being used during winter operations. Also, similar to previous years, winter road salt will continue to be supplied, on a pay per use basis, from the MTO Highway 17A Kenora Bypass patrol yard.
