## **Background:**

One of the key recommendations of the Lake Capacity and Management Study for Black Sturgeon Lake is to undertake regular water quality monitoring. The Planning and Development Department prepared a consultant's terms for the completion of this work.

On May 28, 2009 Council adopted the following resolution:

- 7. Moved by W. Cuthbert, Seconded by C. Van Walleghem & Carried: THAT Council hereby receives the following RFP's for the purpose of undertaking water quality monitoring on Black Sturgeon Lake:
  - Ryan Haines \$31,104 (plus GST)
  - DST \$33, 679 (plus GST); and

THAT Council of the City of Kenora hereby accepts the Proposal received from Ryan Haines, commencing in 2009 in the amount of \$14,635 (as set out in his proposal), with an option for a contract extension in 2010 in the amount of \$16,469, conditional upon Council's funding approval in the 2010 budget for this purpose; and further;

THAT Council gives three readings to a by-law authorizing the Mayor and Clerk to execute a contract for this purpose.

Budget: 2010 Non-capital special projects/unusual spending - \$16,469 (plus applicable taxes);
