

Minutes

Of a Special Meeting of the Council of the City of Kenora Monday, February 8, 2010 – City Council Chambers 3:00 p.m.

With Mayor L. Compton in the Chair, Councillor W. Cuthbert, Councillor C.

Call to Order

Mayor Compton called the Special Meeting to order.

Public Information Notices

Take Notice that in keeping with Notice By-law #144-2007 Council intends to approve the following at its February 8, Special Council Meeting:

Councillor McMillan advised that since the January 13, 2010 budget discussions he pursued an opinion and therefore advised of a Declaration of Pecuniary Interest on Resolution Numbers 1 and 5 on today's agenda due to the Kenora Police Services Board (KPSB) budget. Councillor McMillan indicated his spouse is an appointed Member of the Kenora Police Services Board and remuneration to members of the Board is addressed and the KPSB budget forms part of the overall City budget (for purposes of setting the mill rate).

Increase in Water and Sewer Rates

Whereas at the Budget Committee meeting held January 7, 2010, the Budget Committee recommended a rate increase of 5% on water and sewer rates effective July 1, 2010; and

Whereas the Harmonized Sales Tax, or HST, also comes into effect on July 1, 2010; and

Whereas it is important that there be a clear distinction between the impact of increases in local rates and the impact of a new tax by the Province;

Now therefore, let it be resolved that following approval of By-Law 19-2010, being a By-law to approve the 2010 Water & Sewer Utility Budget, Council hereby gives three readings to a By-law to amend Schedule "D", Table (i) to By-Law 168-2004, being a By-Law to establish water and sewer rates, to incorporate a 5% rate increase effective April 1, 2010; and further

That in accordance with Notice By-Law Number 144-2007, public notice is hereby given that Council intends to amend the City's water and sewer rates at the February 8 Special Council Meeting.

Adoption of 2010 Operating/Capital Budget By-law
