## **Presentations:**

- Navy Centennial Namesake Picture Presentation Paul Staff and from the Naval Reserve Unit in Winnipeg representing the Canadian Navy at HMCS Chippawa spoke in regards to the fact that this year (2010) marks the 100<sup>th</sup> year of the Canadian Navy Bringing the Navy to Canadians, Connecting with Canadians is the theme. Local Master Seaman Mastromatteo was also present for the presentation to Council. The presentation included a portrait of the HMCS Kenora with historical information on the ship that will be given to the Museum for display. There were 83 crew on this ship and the only Kenora citizen who sailed on that ship was in attendance for the presentation, Mr. Orville Muggaberg.
- **Presentation to Grace Kozak** Ms. Kozak lives in Keewatin and has been there for approximately 62 years. She is extremely active being an avid curler, swimmer and regularly sings in the St. Andrews Church choir. Ms. Kozak has picked garbage along Highway 596 for over 56 years and the City is extremely thankful for her dedication as a volunteer for many years. Council presented Ms. Kozak with a Certificate of Appreciation.

As of late she is a volunteer for the Keewatin Homecoming events which is held annually on July 1st.
