## **Background:**

Within the next couple of months all Service Ontario programs will be re-located to 220 Main Street from the government building on Robertson Street. They will be co-occupants of the Land Registry Office.

James Tkachyk, Facility Manager, has requested that the City provide a barrier free parking space in front of the building to accommodate the many seniors and disabled clients who will be accessing the site.

The request has been reviewed by the City Engineering staff and the Accessibility Committee and provisions have been made for the installation of one barrier free parking space with painted grid walk area to be completed as part of the sidewalk works approved under the 2010 Capital budget.

This change will require an amendment to the Traffic Regulation By-Law #127-2001. Also to be included in the amendment are other changes to barrier free spaces within the downtown core not already approved by by-law: removal of the space fronting Quilter's Quarters and the conversion of the single space to a double space fronting King Furniture.

I recommend that the City of Kenora Traffic Regulation By-Law 127-2001 Schedule "K" Disabled Parking on Streets and Highways be amended as follows:
