Presentation:

Lake of the Woods Water Quality Program - Ryan Haines from Ryan Haines Consulting described the purpose of the project is to realize measurable improvements to water quality of Lake of the Woods within five years. There are three components to this project; water quality improvement project identification; education and outreach; and water quality monitoring.

An important component of this program is tracking the results of water protection/rehabilitation projects. There is currently extensive water quality data for

Lake of the Woods. However, water quality data is scarce for the lakes and rivers that flow into the Lake of the Woods (with the exception of Rainy River). As part of the first year of this project gaps in water quality data will be identified and filled. Information collected will include phosphorous values taken during spring turnover and dissolved oxygen and algal genera identification during mid-summer. It is the long-term goal to measure these parameters once every five years to measure the success of water quality initiatives on each water body.

Ryan is seeking a letter of intent from Council for funding for 2011 of \$10,000 along with the support of Council for the project to proceed.
