#### 8. 2009 Overtime Report

**Discussion:** Operations Manager Rick Perchuk described the difficulties in the reporting of overtime. Weather conditions result in most of the Sewer and Water and Roads department overtime. These are difficult to predict and control. The departments are a seven day operation and statutory holidays appear as overtime in the reporting. The report also does not reflect inter-department charges amongst the departments for road works, water and sewer breaks, etc. The recovery costs charged to customers also does not reflect the revenue that covers the cost of the overtime amounts. Chief Brinkman stated that the overtime in the Fire and Emergency Services department were primarily attributed to mandatory training that was required. Bill Preisentanz noted that the police overtime was for a 6 month period only up to July 17, 2009, prior to disbandment.

The Ontario Power Authority has announced the Community Challenge in Ontario encouraging all Ontarians to take simple conservation actions that will have lasting financial rewards and help fight climate change. The primary focus is on 'phantom power' which accounts for up to 15% of residential electricity bills. This will be a five month campaign to encourage

sustainability by getting Ontarians to think beyond "Earth Hour" (August 11, 2010). Ontarians who sign up for the challenge will receive 20 AIR MILES reward miles and an additional 10 AIR MILES Reward Miles will be donated to a participating charity.

The municipality that wins the challenge in each of the three tier categories of municipalities will earn \$10,000 that will be designate towards a conservation initiative. A committee will be formed to work on this campaign and promotion of this 4 month initiative.
