#### **Call to Order**

Mayor Canfield called the meeting to order and Councillor Roussin read the Prayer.

Mayor Canfield presented Laureen Parsons and Ted Szajewski with Volunteer Awards from Ontario Heritage Trust in recognition of their volunteering time and energy to preserving and promoting Kenora's heritage.

## **Deputations**

#### Len Kropioski

Mr. Kropioski attended to express his concern on a situation which has manifested at the entrance to his home located at 45 Third Avenue West.

The snow has been piling up and blocking the fire hydrant in front of his residence and the fence on the west side of the property is the main entrance to his home with a fire hydrant located on the right hand side of the entrance not 5 ft. from his fence. Mr. Kropioski advised he has contacted both the Kenora Fire Department and the Kenora OPP to express his concerns. Chief Brinkman had advised there is a City bylaw that clearly states that parking in front of, or blocking a fire hydrant within 3 metres is prohibited; and at this location the there are mounds of snow piled around his fence and the fire hydrant.

Mr. Kropioski appealed to Council to review its snow removal policy and to look into this matter as soon as possible. As a taxpayer he believes he should not have to be calling the various departments or attending a Council meeting to make sure this issue is addressed. Mr. Kropioski circulated photos of the snow and the subject area and provided the Clerk with a copy of his presentation.

In closing, Mr. Kropioski acknowledged Councillor Ron Lunny for supporting the reinstatement of parking for Veterans' in the city.

Mayor Canfield thanked Mr. Kropioski for his deputation and advised the City will look into addressing this matter as soon as possible.

- The City will not sell the tower bell or the alarm box with bell in conjunction with any sale of the new emergency services facility located on Fourteenth St. N., but will relocate these items either to a new emergency services facility within City boundaries or return them to the original heritage structure on Second St. S. at City cost; and
- The City will return the tower bell and the alarm box with bell to the Kenora Fire Hall heritage structure on Second St. S., at City cost, should these items ever become surplus to City needs or considered no longer required; and further

That despite the exemption as provided under Section 30.1 (2) of the Ontario Heritage Act for this amendment, Council hereby directs administration to proceed with the notice provisions and applicable appeal period as required within Section 30.1 (1) of that Act.
