Reading of Public Notices

A by-law to amend the 2011 Capital Budget to increase the total cost for the amphitheatre cover project from the original \$1.5 million allocation to \$1.6 million.

That Council hereby approves amending its 2011 capital budget to increase the total cost for the amphitheatre cover project to \$1.6 million from the original \$1.5 million allocation; and

That Council hereby approves this incremental \$100,000.00 to be funded through the City's Contingency Reserve; and further

That in accordance with Notice By-law Number 144-2007, public notice be hereby given that Council intends to amend its 2011 Municipal Operating and Municipal Five Year Capital Plan at its May 16^{th} Council meeting.
