**2. OPP Community Services Officer Reports**

Dave mentioned that Police Week is May 15 to 21 this year and he is working on some programs for Police Week. One thing he hopes to have in place is a day where the public can attend to see all the OPP equipment and other police items and perhaps this Committee would like to use that day as a fundraiser to sell burgers, etc.

Dave indicated the display would likely be held at or near Central Park or the Kenora Curling Club, and although it would be great to bring this type of stuff to Kenora other OPP detachments in the Region may also want to have the equipment on display in other locations. Another suggestion is to have an Open House at the OPP office. The Kenora Home Show was also mentioned and Dave advised he has approached the Fire Hall and Safe Communities and that the Committee is very interested in partnering with the OPP.
