# • Black Sturgeon Water Monitoring Report Presentation, Ryan Haines Consulting

All shield lakes are getting more eutrophic over time and although this is a natural process, we want to make sure that human impacts are not accelerating the process. In 2009 the recommended study was for two sites, site # 3 (near East Melick Rd) and site #2 (near Dalles Rd) one near lower Black Sturgeon and one heading out of Black Sturgeon. Site X was added for 2010 season. Cool water species such as lake whitefish and cisco had a period of a shortage of oxygen or too high temperature for between 27 & 91 days. Similar findings obtained during 2009 sampling season and by OMNR in 1988. Future global impacts such as global warming and local impacts such as increased nutrient loading are cause for concern. Phosphorous concentrations in 2010 were higher than those found during the 2009 season, likely due to warm, wet summer (2009 and 2010 sampling seasons provide excellent range for baseline data). Potential flushing may affect ability to monitor impacts of development. Phosphorous results from site X indicate that higher levels of phosphorous at inlet of Lower Black Sturgeon (site #3) are not due to inputs from Upper Black Sturgeon.

Recommendations from the Black Sturgeon Water Monitoring study outlines that the data collected sets from 2009 and 2010 provide an excellent baseline using two different seasonal patterns and should be used as the acceptable range for future monitoring efforts. Monitoring efforts should be considered being tested annually or at a minimum less than every 5 years. Also, there may be value in determining the output of nutrients from Black Sturgeon to the Winnipeg River system at outlet. Mr. Haines left his presentation with the Clerk and Council thanked Mr. Haines for his presentation. Presentation ended at 9:53 a.m.

## 1. Transfer of Surplus Lands- 122 Minto Crescent

#### **Recommendation:**

**That** Council of the City Kenora authorizes the Mayor and Clerk to enter into an agreement to transfer municipal property described as LOT 13 of Plan M-586, PCL 31166, 122 Minto Crescent to Aamikkowiish Non-profit Housing; and

**That** in accordance with Notice By-law #14-2003, arrangements be made to advertise the sale of the subject lands for a three-week period; and further

**That** the Municipal Solicitor be directed to affect the transfer conditional upon a stacked dwelling (duplex) be constructed within two years of the transfer date; and that the property not be re-sold/transferred, other than to another non-profit housing agency, within ten years of the date of transfer of lands.
