#### Call to Order

Mayor Canfield called the meeting to order and Councillor McMillan read the Prayer.

#### Presentations:

#### **Kenora Youth Council Term Report**

The Kenora Youth Council members attended and thanked Council for the opportunity to become more involved in the City. They expressed that it has been a great experience for the youth involved and they look forward to improving and growing as a group in the next term. The Youth Council plans to host a community barbeque that will give back to the community and half the proceeds will go to local charities. In the next term, the Youth Council plans to create a code of conduct for members as well as develop a basic guide for how the Council works. Mayor Canfield thanked the members present and a copy of the deputation was left with the Clerk.

#### **Kenora OPP 2011 Year-End Report**

Inspector Dave Lucas presented Council with the 2011 year-end report for the Kenora OPP. He stated that alcohol and drugs continue to fuel the vast majority of violence,

property crime, street crime and disorder in the City. In 2011 they saw an increase in property crimes, however, they are ensuring that prolific drug dealers and repeat offenders are held accountable for their crimes. In the City alone they responded to 15,000 occurrences with violent crimes down and property crimes up slightly. For the total overall detachment they responded 18,325 occurrences with violent crimes also being down and property crimes increased. The detachment reported 21,460 hours of total patrol in strictly the City alone. In 2011 they solved 31.2% of the property crimes and 82.5% of violent crimes.

The detachment focuses on crime prevention through social development along with a focus on substance abuse, mental health and youth issues. They have introduced a program called "Opening Doors After School" program running out of Evergreen School and this program has been very successful. Strengthening families for the future will continue and it is bringing families together and will continue to run in 2012. The OPP also have held prescription opiate education sessions with the public as well as the local and visiting doctors. Bob Bernie is the lead on the Substance Abuse and Mental Health Task Force. They have also completed safety and enforcement presentations to community members and the OPP link to all health, social services and other community resources to form positive relationships in the community.

The detachment has 88 total police officers in detachment. The focus for 2012 is to continue to reduce violent crime and victimization, reduce mischief, break and enter, and auto theft. They want to continue to address street crime and disorder, substance abuse and mental health. They will continue their great work with supporting youth relationships, continuing with ATV, Snowmobile and water units and overall improved public relations.

Carol Davis and George Storm were present to present the City of Kenora and Chief Warren Brinkman with a plaque from the Portraits of Honour display that was in Kenora last fall. Carol and George thanked the Fire Department and the Kenora Kinsmen for their support and assistance in bringing the Portraits of Honour to Kenora and presented the plaque to be displayed at the new Fire Hall.

That Council hereby approves an amendment to the Discharge of Firearms By-law #148-2010 to authorize an extension to the areas in which deer hunting is allowed within City limits for 2012 for the period October 1, 2012 up to and including 15 December, 2012, with the following restrictions:

- Hunting shall be restricted to hunting of deer only south of Highway 17A (the Bypass);
- Firearms authorized to be used for hunting within City limits south of the by-pass shall be restricted to archery equipment as defined per the rules and regulations of the Fish and Wildlife Conservation Act;
- Hunters eligible to hunt within City limits south of Highway 17A (the By-pass) shall be restricted to those eligible to hunt under the Resident – Open Season, as defined within the Ontario hunting regulations;
- Hunters shall have all required licenses and courses and comply with the rules and regulations as set out in the Fish and Wildlife Conservation Act and adhere to all related Provincial and Federal statutes;
- Hunting shall only be permitted on parcels of land of an area of four (4) hectares or greater;
- Hunting shall be prohibited on all city owned land;
- Hunting shall only take place on either crown land or private property which lies within the designated hunting areas and related size restrictions;
- Hunters must obtain written permission to hunt on private land from the property owner and display written permission at request of a law or by-law enforcement officer;
- Discharging a bow and arrow within 75 metres of an occupied dwelling or roadway is prohibited;
- No bow and arrow shall be discharged in the direction of any human, roadway, structure or domestic animal within reasonable range of the weapon at an angle which might allow the projectile to strike at, or dangerously near these objects;
- Field dressing shall be done in accordance with the wishes of the property owner and remains shall not be disposed of on City property; and further

That the appropriate by-law be passed for this purpose
