D. Commission Deputations or Presentations:

Betty Wires - LOWAC

Betty Wires from the Lake of the Woods Arts Collective presented an overview of their group and the history of how the group was formed. They bring together artists of all disciplines including those involved with music, visual art, performing arts and writing. The collective is striving to meet the needs of all arts and artists in the area. They have over 100 members which include artists, businesses, organizations, schools, members at large and summer/local residents. It is supported 100% by volunteers and funding comes from the nominal membership fee of \$25 as well as exhibits and sales, the Coney Island Music Festival and grants. They have had many community events including 2x2 4 U Art Exhibit & Sale, Canada Day partnerships, Coney Island Music Festival, Studio Tours, Cultural days, the Celebrate Summer Aboriginal Festival, Shoephoria Exhibit 2011, Word on the Water, Festival of Trees and new for 2013 will be Muskies on Main. They have expanded their programming in art for kids, photographing your art workshop, Ontario Craft Council and SOAR. They are working on strengthening their business platform and will soon become incorporated as a not-for-profit group. They wish to provide inspiration for artists of all genres and build networks and partnerships in the community. Moving forward, LOWAC would like partnership opportunities,

joint promotion with the City and business organizations for Art events in the community, participation on City committees related to economic, tourism and education/training development and operational support to grow LOWAC events. Dennis Wallace thanked Betty for her presentation and she left a copy of her presentation with the Commission along with a copy of the Synergy Newsletter and a copy of the Annual Report (October 2011).
