# Flying Lanterns

## 18. Moved by C. Drinkwalter, Seconded by R. McMillan.

Whereas flying lanterns are a sky lantern also known as Kongming lantern or Chinese lantern which is a small hot air balloon made of paper with an opening at the bottom where a small fire is suspended to fly the lanterns; and

Whereas in recent years there has been growing concern about their potential to cause fires and harm animals that may eat their remains and several countries have banned these lanterns for these reasons; and

Whereas these lanterns pose a serious fire safety hazard as they are fuelled by an open flame and can travel for miles before potentially landing on trees, building roof tops, or other combustible properties leaving a potential disaster especially in Northwestern Ontario;

Therefore be it Resolved That Council of the City of Kenora request the Provincial Government to have Flying Lanterns banned from use and sale in the Province of Ontario and further;

That Council of the City of Kenora circulates this resolution to all Ontario Municipalities for endorsement and support; and further

That the City of Kenora Fire and Emergency Services initiate enforcement action when the identity of the owner of the device can be determined, through appropriate sections of the Ontario Fire Code.

# Amendment to Discharge of Firearms Bylaw – Deer Hunting 25. Moved by R. Lunny, Seconded by R. McMillan & Carried:-

That Council hereby approves an amendment to the Discharge of Firearms By-law #148-2010 to authorize an extension to the areas in which deer hunting is allowed within City limits for 2013 for the period September 1, 2013 up to and including 15 December, 2013, with the following restrictions:

- Hunting shall be restricted to hunting of deer only south of Highway 17A (the By-pass);
- Firearms authorized to be used for hunting within City limits south of the bypass shall be restricted to archery equipment as defined per the rules and regulations of the Fish and Wildlife Conservation Act;
- Hunters eligible to hunt within City limits south of Highway 17A (the By-pass) shall be restricted to those eligible to hunt under the Resident – Open Season, as defined within the Ontario hunting regulations;
- Hunters shall have all required licenses and courses and comply with the rules and regulations as set out in the Fish and Wildlife Conservation Act and adhere to all related Provincial and Federal statutes;
- Hunting shall only be permitted on parcels of land of an area of five (5) acres (metric equivalent is 2.023428 hectares) or greater, as mapped;
- Hunting shall be prohibited on all city owned land;

- Hunting shall only take place on either crown land or private property which lies within the designated hunting areas and related size restrictions, as mapped;
- Hunters must obtain written permission to hunt on private land from the property owner and display written permission at request of a law or by-law enforcement officer;
- Discharging a bow and arrow within 75 metres of an occupied dwelling or roadway is prohibited;
- No bow and arrow shall be discharged in the direction of any human, roadway, structure or domestic animal within reasonable range of the weapon at an angle which might allow the projectile to strike at, or dangerously near these objects;
- Field dressing shall be done in accordance with the wishes of the property owner and remains shall not be disposed of on City property; and further

That the appropriate by-law be passed for this purpose.
