#### **Presentations**

Mayor Canfield called upon Ron Baker as well as other Executive Members of the CP Retirees Club in attendance to accept the CP Station clock the City has decided to retire back to CP for the Railroad Museum in Norman. It was noted the clock had originally been donated to the former Town of Kenora by CP in recognition of the Town's centennial celebration in 1982. On behalf of the Club, Ron Baker gladly accepted the clock and thanked Council very much for returning the clock to the CP Club for their Museum; they were happy to have it back among those who relied upon the clock for many years during their working career at CPRail.

### **Deputations**

# Susan McLeod – Lake of the Woods District Property Owners Association (LOWDPOA)

Susan McLeod, Executive Director of the Association addressed Council on concerns relating to the flying lantern issue. She noted this spring the Association received a number of concerns on the issue and the potential hazards. She indicated for 2013 the lanterns have been updated with extended flying times of up to approx. 20 minutes and on a breezy day they can travel for quite a distance, indicating there is virtually nothing the most conscientious person can do to stop them when they're in flight. LOWDPOA would like to have them banned for sale and use, not only locally but provincially as well. She referred to the Forest Fire Protection Act and that it does not permit a person to discharge a firearm, flare, fireworks or explosive in or within 300 metres of a forest area, and yet these lanterns can be flown and because of their flight nature, it cannot be determined if they're extinguished or not.

Susan advised there has been huge interest and concerns over these lanterns in terms of the forests, and cottages and homes. She was thankful albeit surprised for the amount of media coverage the lanterns have received, and she noted some retail outlets have removed the lanterns from their shelves. Susan indicated she and Chief Brinkman have met on the subject and apparently Chief Brinkman will be submitting a report to the July Committee meeting. In closing, Susan indicated LOWDPOA is requesting Council's support for the banning of these lanterns in Kenora with hopes for a provincial ban similar to what some eastern provinces have already put in place. Susan provided copies of deputation to the Clerk and she was thanked for attending.

That should the CP Retiree Club cease operations in Kenora, the station clock be returned to the City of Kenora to determine a suitable location for the clock and/or to turn it over to the Lake of the Woods Museum.

#### **Waste Reduction Act**

Whereas the Province has introduced proposed legislation entitled the Waste Reduction Act; and

Whereas this proposed legislation will hold individual producers responsible for managing the waste from their products and packaging; and

Whereas this proposed legislation will encourage increased waste diversion from landfills, which will result in fostering innovation and more efficient packaging, as well as help both extend the life expectancy of existing landfill sites and reduce the need for new landfill sites; and

Whereas this new legislation recognizes municipalities' important role in waste diversion while working to ensure that the taxpayer relief through greater industry funding for the Blue Box program in the long term;

Now therefore, let it be resolved that the Council of the City of Kenora hereby supports the proposed changes under the new Waste Reduction Act for the reasons as outlined within this resolution; and further

That a copy of this resolution be sent to the Honourable Jim Bradley, Minister of the Environment, Sarah Campbell, MPP (Kenora–Rainy River), as well as submitted to Wendy Ren, Assistant Director, Ministry of the Environment, in conjunction with the Province's consultation on this proposed legislation with reference to EBR Registry Number 011-9260.
