Lake of the Woods Centre for the Arts – Dean Carrie

Dean Carrie is a Director and Treasurer of the Lake of the Woods Centre for the Arts Charitable Corporation or "LOWCA" which was founded in 2010 by a number of citizens who wished to carry on the quest for a centre for the arts in Kenora. LOWCA is a not-forprofit corporation registered in Ontario which currently has 243 registered members.

There has been a long history of municipal committees and other groups who have worked towards a goal of having an arts centre in Kenora. Their mission statement reads, "Building a centre for the arts through community support for area residents and visitors."

LOWCA would like to express their support for the inclusion of a performing arts centre in the Event Centre which is proposed to be added to the existing Kenora Recreation Centre. Dean pointed out that the Request for Proposals for the Provision of Professional Conceptual Design and Feasibility Planning Services which was issued by the City in September 2013 indicated that the facility would "act as a concert and conference facility." LOWCA believes that we now have a golden opportunity to build a first class performing arts centre in Kenora.

Mr. Carrie stated that a performing arts centre with a flexible configuration that allows for multiple uses, such as meetings, conferences, music, theatre, and dance can be an economic driver and job creator for the community. A performing arts centre can share lobby space, food services, washrooms, and parking with other activities at the rec centre. The lobby area itself could act as a public art gallery for local artists.

LOWCA is encouraging the City to explore an operating partnership with LOWCA for the operation of the performing arts centre and invited members of Council to attend their Annual General Meeting on Monday, November 4th at 6:30 p.m. at The Bijou Restaurant in Kenora. Mayor Canfield thanked Mr. Carrie for his presentation and a copy was left with the Clerk.

Discovery Centre Rentals

Site Plan Agreement - Coker
