1. K.D.S.B. Monthly Report from Councillor Roussin

At its regular board meeting of Thursday, March 21, 2013, the KDSB Board of Directors addressed the following issues: Adopted a resolution to request permission from the Minister of Municipal Affairs & Housing for the possible disposition of some social housing projects located in Ear Falls, Minaki, Dinorwic and Hudson. The resolution is the first step in a long process to potentially dispose of the identified properties. Any final sale or disposition of these properties is subject to provincial and Board of Director approval. Defeated a resolution to identify the Nestor Falls Ambulance Base for potential closure as per board policy. As a result, the NF Ambulance Base will not be considered for closure. Reviewed 2012 - 4th Quarter Financial Reports for Early Learning & Child Care, Ontario Works, Housing, Integrated Services and Land Ambulance operations. All departments are performing well within their respective budgets. It was reported by the administration that the joint Land Ambulance Non-Emergent Transfer Study being undertaken with the Rainy River District Social Services Area Board; ORNGE, Ontario's air ambulance service and the seven NWO regional hospitals (Kenora, Red Lake, Dryden, Sioux Lookout, Fort Frances, Atikokan, and Thunder Bay) should be completed in early April. Councillor Roussin provided copies of the Press Release from KDSB to members of Council and the media.

2. Changes to Natural Resources Fish & Wildlife Regulations Recommendation:

Whereas tourist camps in Northwestern Ontario are experiencing an annual decrease in the number of tourists visiting from the United States of America; and

Whereas Kenora and many Northwestern Ontario communities greatly depend on the tourism industry for sustainability of many businesses and services in their communities; and

Whereas traditionally American hunters have represented a large percentage of the tourists that occupy our tourist camps annually and continuing to draw visitors north of the border remains a challenge each year; and Whereas the wolf population in wildlife management areas 3, 6 and 7 along with others in the north continues to grow, this over population has had negative effects on other species inhabiting the same space and the moose population in these specific wildlife management areas is now nearly non-existent;

Therefore may it be Resolved That changes to the current Natural Resources Fish and Wildlife Regulations include the following:

The wolf hunting season be extended by one month in order to coincide with the fall bear hunt, beginning August 15th each year; and

The price of a wolf license for non-residents be reduced including the requirement for an Outdoors card and small game license; and

That the Province of Ontario re-instates the spring bear hunt; and

That the out of Province deer hunters are required to stay at a licensed tourist establishment; and further

That these proposed changes will help grow and rebuild the moose population in the Kenora area and entice more tourists into our province improving the economy of northern areas that are dependent upon those tourism dollars.

7. Capping Options 2013 Recommendation:
