# D. Presentations/Deputations:

### • Eric Lovas – Co-ot Taxi

Eric Lovas, Manager and Co-owner of Co-ot Taxi attended to address the proposed new Taxi By-law that is scheduled to be adopted at Council's meeting next week. Specifically he inquired if the City would consider an increase to the age of vehicles from 10 to 15 years and whether or not mechanical fitness inspection requirements would be changing from twice to once per year. It was confirmed the new by-law provides for one annual inspection. Since the rate increase was denied, Eric referred to the possibility of the taxi companies becoming self-regulated in terms of establishing their own fares and that broker and vehicle licencing as well as other regulations would still fall within the City's by-law.

Mike Mostow gave an overview of the former process with KPS and the requirement for safety checks with use of safety lanes for both a visual and braking/road inspection. It was noted the City has the right to regulate the annual inspections through our by-law. Mike does not agree with extending the age of taxis to 15 years and he gave a summary of requirements of other municipalities in the area and that Kenora is most lenient in terms of this requirement at 10 years and he would not support extending it. The Clerk advised this item may be further discussed under the Business Administration section of today's agenda. Eric was thanked for attending and he left the meeting at 3:45 p.m.

## • Lake of the Woods Development Commission Q4 Report

Mort Goss, Commission Vice-Chair provided the Q4 report to Committee and reviewed the following as per the Power Point Presentation:-

- Skating rink at the Whitecap Pavilion opened this winter and is used nearly every day;
  - 2012 visitor statistics are up 45%;

 25 funding applications completed in 2012 totaling over \$1.2 million. Mort also highlighted the Lake of the Woods Project, Tourism Projects, Hidden Gems Project and Infrastructure Projects as well as various business developments such as Casino Project, LOW Brewing Company. 80% of new jobs come from existing businesses in the community, and he referred to Wincrief, Miisun, Weyerhaeuser, and Kenora Forest Products. Other areas touched on included the Discovery Centre Internal Displays, Training and Hospitality, Special Events, and Farmers' Market for 2013. In closing Mort reviewed what's on the horizon this year in terms of activities, marketing and other projects.

Mort and Commission Members were thanked for attending and they left the meeting at 4:05 p.m.
