1 Call to Order

The meeting was called to order at 9:32 am.

2 Declaration of Pecuniary Interest

None declared.

3 Acceptance of Minutes from Meeting held February 7, 2013

Motion: Moved by Gloria Alcock, seconded by Jim Clarke that the minutes of the meeting held February 7, 2013 be accepted as presented. Carried.

4 **CIP Applications**

Lake of the Woods Brewing Company - 350 Second Street South and 70 Park Street

Discussion centred around 70 Park Street and, in particular, the need for further clarification regarding the facade improvements so that what is presented in text, image and costing are in sync. Taras Manzie did provide a cost breakdown as requested at the last meeting. Lori Nelson will follow up with Taras.

Good Things - 325 Second Street South

Tara Rickaby followed up with Brent Lundy regarding: the requirement of permits (signage, etc.); the secondary facade grant (for the building face on the lane side); eligible landscaping elements; the BIZ window box program; and finally the possibility of waiving certain fees like building permit. The committee is still awaiting the plan and costing for the lane-facing facade.

Borrelli's - 130 Main Street South

Lori Nelson followed up with Andrea Borrelli and Kevin Robertson re: the proposed signage for 130 Main Street South (waterfront side). Andrea indicated that the roof-top signage is in front of her office windows so will not be obstructing another tenant's view. Kevin Robertson indicated that all three signs would require a variance.

Motion: Moved by Jim Clarke, seconded by Jeff Port to approve additional CIP funding of \$505.20 for the roof-top signage for Borrelli's at 130 Main Street South, bringing their total up to the maximum of \$2,000 based on a combined quote of \$5601.25 for three signs, and further that this approval does not preclude the applicant from complying with the requirements of the sign permit process. Carried.

Mink Bay Wetlands

Barb Manson reported that she and Lisa Moncrief had met to discuss the possibility of a district designation for the Mink Bay Wetlands. They have decided that this is not the route to go. Ontario Heritage Conference

Tara Rickaby reported that Council passed the addition of the Toole House and the Blue Heron to the Municipal Registry.
