#### Call to Order

Mayor Canfield called the meeting to order.

Councillor McMillan made a Declaration referring to Motion Number(s) 6, 7 and 8 on today's agenda as it pertains to the Kenora Police Services Board, to which his spouse is a Member, and receives remuneration.

# **Deputations**

#### 1. Bill Cameron – on behalf of Cameron Narrows Residents

Bill Cameron, a resident of Cameron Narrows, made a deputation to Council on behalf of Cameron Narrows residents. The group is requesting that Council pass a by-law limiting the speed of boats in Cameron Narrows to 9km/h and/or establish a No Wake Zone from Cameron Narrows to the northeast point of Coney Island, and the mainland to the east opposite that point.

Mr. Cameron indicated that he is representing ten families on the City side of the narrows and eight families on the Coney side. The Coney people are especially at risk as they have to cross the narrows at ninety degrees through the fast traffic in small open tin boats to get to their properties. He mentioned a letter he had previously sent to Council members which provided examples of dangerous driving and accidents that have occurred there, most resulting from speed.

The main reason for the residents' request is safety, although with the effects of this year's high water levels, damages have occurred to docks and there has been flooding of properties. Bill provided specifics on where the residents feel the 9km/hr and No Wake Zone signs should go, and suggested that the police will then have the ability to enforce them during high traffic times. It was questioned how speed limits posted on other areas of the lake are regulated and enforced. In closing Mr. Cameron thanked Council for their consideration and indicated that ensuring there are safe waters to boat on should be part of the City's priority in being a boating destination.

Mayor Canfield thanked Mr. Cameron for his deputation and a copy was left with the Clerk.

#### 2. Clint Thorsteinson – on behalf of Gunne Crescent Residents

Clint Thorsteinson, a resident of Gunne Crescent, made a deputation to Council on behalf of several Gunne Crescent residents. Residents are concerned that they will have major water issues at their properties in the future as a result of permits issued for Kenora Catholic District School Board's expansion project. Mr. Thorsteinson explained that the storm water system is designed so that the water will drain right onto Gunne Crescent. He questioned why the storm sewers cannot be directed to run into the swamp behind the school instead. Residents are afraid of what will happen to their homes from the drainage into the sewers and ditches, even if the storm sewer is replaced on Gunne Crescent. Clint indicated that a meeting was held with school board representatives and no responsibility will be taken if properties are flooded.

Mayor Canfield thanked Mr. Thorsteinson for his deputation and photos were left with the Clerk.

# **Establishment of a Port Authority Advisory Committee**

# 1C. Moved by R. Lunny, Seconded by C. Gallivan & Carried:-

That Council gives three readings to a by-law to establish a Port Authority Advisory Committee for the City of Kenora and to adopt a Terms of Reference for this committee; and further

That members appointed to this Committee will have a term to expire November 30, 2014.

**Discussion:** Heather Kasprick provided the background on the report, the intent is to establish an advisory committee to identify safety and enforcement issues relating to boat, airplane and snowmobile traffic on the waterways in the City and bring recommendations back to Council.

Councillor Smith expressed concerns regarding the establishment of a Port Authority Committee, indicating the City has had one in the past and the Cameron Narrows issue wasn't addressed by the past authority. If the City moves forward with the committee it will take at least five weeks before things move forward and nothing will be addressed this year. Councillor Smith suggested that the issue falls under the mandate of the

current Community Policing Committee, who have the capacity to form ad hoc committees in a timely manner to deal with this, as they are to address community concerns regarding safety in the City. Councillor Smith urged Council not to accept this motion as the issue is time sensitive and the community should not wait any longer. She indicated that there is a process and if the municipality wishes to impose a restriction they can, and suggested immediately moving forward with a public meeting.

Councillor Roussin shared support for Councillor Smith's research and comments, adding that there is a safety issue, and now wakes are damaging properties with the high water levels this year. Councillor Roussin shared that under the Municipal Act the municipality has the mandate to provide a safe and healthy environment, and has authority to protect the property of tax payers. He indicated that the City already has the authority and right to do something about the safety issue, and should do something immediately, while noting liability as another concern.

Council agreed that there is a safety issue, and it was suggested that the speed issue in Cameron Narrows could be addressed by the City installing speed limit signs on land in the area (9km/h-no wake zone), as was suggested in the deputation just received. The authority to do so and the ability to enforce the restrictions was questioned. It was also mentioned that establishing the speed limit could make problems worse elsewhere, such as Devil's Gap. Several members of Council indicated their support for the establishment of a Port Authority Committee as there are many other issues around the area that may or may not be on Lake of the Woods. The Committee will be responsible for gathering all the facts so that there are no assumptions made.

It was suggested to consider the two issues at hand separately. It was discussed that it will take some time and research to be able to put a by-law in place but in the meantime the City will consider placing signs, in addition to putting out some public safety messages. It is anticipated that most boaters will obey the signs and therefore this would improve the situation at a reasonable cost. In the meantime moving forward with the establishment of a Port Authority Advisory Committee will allow for research and consultation to clarify what can be done for issues brought forward on the Lake and on other local bodies of water.

It was asked of the OPP Marine Unit their opinion on the situation. OPP Officer Mike Barclay was present and spoke to the concerns. He indicated that attempts can be made to address the issue in several ways. He informed that the narrows has to be wider than 100 meters before the 10km law speed restriction from the shoreline can be enforced so this cannot be applied. He indicated that Transport Canada are the only ones that can put enforceable restrictions in place and it may take some time and work to make that happen. He added that if signs are placed, the OPP can attempt to address the issues, although they cannot situate themselves at the location all the time as there are many issues of concern all around the Lake this year. OPP have been reviewing damages that have occurred due to the high water levels and believe there is a value in establishing the Port Authority Committee in order to address safety and damages on all navigable waters in the area.

# **Zoning By-law Amendment – Zylstra-Moore**

That Council of the City of Kenora give three readings to a by-law to approve an amendment to Zoning By-law 160-2010 specifically on property described as 1808 Highway 17 West, PT ML 233 PLAN PCL 26309 to rezone from RU - Rural to TR- Tourist Recreation [30] /EP - Environmental Protection. Notwithstanding any other provisions of the By-law, on lands noted by [30] on the Schedules to the By-law the lands shall be zoned to permit a campground/tourist resort, including limited agricultural uses, with accommodations limited to tents and cabins, an outdoor recreation facility, with a maximum of one accessory dwelling unit, and uses and structures normally incidental

to the foregoing. The effect of approval would be to permit the use of the property for low-impact vacations, a private residence, organic gardening, small- scale agricultural use in a manner which is consistent with the Provincial Policy Statement (2014) and the City of Kenora Official Plan (2010).

**Discussion:** There was discussion of the public zoning meeting which took place on July 8, in which some of the neighbouring residents brought forward their concerns regarding the owner's proposed plans for the property. It was acknowledged that the neighbours concerns were taken into consideration by the owners and they have agreed as part of their rezoning application to add an Environmental Protection area as a buffer between the properties. In addition, with regards to best practices, the owners have agreed to post guidelines for responsible wildlife viewing, as well as mention the significance of the importance of the wetland area to their visitors. They will also consider limiting the number of watercraft permitted on Mink Bay at one time.

Charlotte Caron clarified that if the business project is not successful and the proponents end up selling the land in the future, the zoning will remain applied to the land. If future owners wish to change the zoning they would have to go through the same zoning by-law amendment process.
