# **NOMA Application to NEB - Resolution of Support**

Whereas intervening offers the City of Kenora an opportunity to address its concerns for the health and safety of its residents and its concern to protect the Lake of the Woods Watershed and to address the importance of the watershed to the City's economy, tourism and recreation; and

Whereas the City has the option of requesting Intervenor status at the hearings or requesting to submit a Letter of Comment; and

Whereas the City also has the option to request to intervene, as a member of the Northern Ontario Municipal Association (NOMA), with NOMA being the Intervenor; and

Whereas the City's goal is to educate the National Energy Board on the risk of a pipeline failure to the health and safety of residents of the Watershed area and to the land, water and the whole of the natural world embraced by the Watershed, for today and for generations to come; and

Whereas the City's goal is to consider ways and means to educate the public on all aspects of the proposed pipeline and seek input from the residents of Lake of the Woods Watershed, in formulating the issues the City will address with the National Energy Board and the evidence it will present; and

Whereas the City's goal is to ensure if the pipeline is approved it be built, supervised and maintained in accordance with the highest technical standards and with the most comprehensive Emergency Response Plan; and

Whereas the City's goal is to ensure that TransCanada's Emergency Response Plan include the City as a party, entitled to notice of leaks, spills and other concerns about the integrity of the pipeline, and to participate in emergency planning, training and responding; and

Whereas the City's goal is to ensure that TransCanada involves the City in every stage of development, construction and operation of the pipeline to ensure that the City's interests in health, safety and protection of the environment are addressed;

Therefore be it Resolved that the City of Kenora request NOMA to intervene in the National Energy Board hearings on Energy East on behalf of the City of Kenora and member Municipalities; and further

That a copy of this resolution be forwarded to the municipalities of NOMA, its Member of Parliament and Member of the Provincial Legislature.

Therefore be it Resolved that the City of Kenora request NOMA to intervene in the National Energy Board hearings on Energy East on behalf of the City of Kenora and member Municipalities; and

That the City of Kenora, on its own and apart from NOMA, consider becoming an Intervenor; and

That the City of Kenora, on its own and apart from NOMA, consider requesting to submit a Letter of Comment; and further

That a copy of this resolution be forwarded to the municipalities of NOMA, its Member of Parliament and Member of the Provincial Legislature.

**Discussion:** Councillor Roussin shared concerns and asked for clarification on the amended resolution. He inquired if once intervenor status is applied for as a group by NOMA would the City be able to apply on its own as he is under the understanding there is no recourse for an individual who has joined a group for intervenor status. Mayor Canfield confirmed that both groups can make application for intervenor status, the amended resolution will allow the City the opportunity to apply for the intervenor status if NOMA does not. When the NEB gives notice for applications, the amended resolution (18A) will cover the City should it choose to apply on its own. Mayor Canfield indicated that NOMA's intent is to include all municipal concerns and that no one will fall through the cracks, adding that the amended resolution should satisfy all concerns.
