## 4. Deputations

## 4.1. Rotary Club of Kenora - Fred Wright

Fred Wright, President of the Rotary Club of Kenora was present to make a deputation to Council behalf of Rotary International and the Kenora Rotary Club. Fred provided a brief history of the local club, highlights of the past year, and some information on their upcoming projects.

Rotary International was started in Chicago by Paul Harris on February 23, 1905. There are now more than 1.2 million Rotarians worldwide in more than 33,000 clubs. Rotary Club of Kenora was established on February 20, 1920 and currently has 56 members. The Rotary Club raises and re-distributes more than \$60,000 per year to our local economy. Recent project include; almost \$10,000 contributed to local school breakfast programs, \$1,500 to Triple P.L.A.Y., \$5,000 to Habitat for Humanity, \$1,000 to Kenora Winter Carnival, and \$10,000 for the new Indoor Soccer Complex. In addition the local club contributes more than \$12,000 annually to international projects. Upcoming events include the Rotary Beach Party to be held on February 21st to raise funds for Polio Plus, which will help more countries become polio free.

Fred thanked the City of Kenora for supporting the club and proclaiming the month of February as International Rotary Month.

Mayor Canfield thanked Fred for his presentation.

#### 5. Presentations

#### 5.1. Kenora District Services Board - Dan McNeill

Dan McNeill, CEO of the Kenora District Services Board (KDSB) made a presentation to Mayor and Council on behalf of the KDSB. He indicated that this is a presentation that they would like to do annually to inform Council and the public of ongoing operations of the services board.

Some history and facts were provided for KDSB, a District Social Services Administration Board (DSSAB) created by the Province of Ontario in 1999 to deliver four core mandated social services including Ontario Works, Social Housing, Land Ambulance and Child Care/Early Years on a regional (Kenora District) vs. local (Community by Community) basis. DSSAB's are Northern Ontario entities created to provide the designated services on behalf of its member municipalities. KDSB is one of 10 DSSABs in Ontario and has 13 board members serving approximately 60,000 people in nine municipalities and four unincorporated territories. The KDSB is a regional organization required to deliver services on a regional basis.

The method of allocating the Local Share property tax share was explained, a component of the of the KDSB budget which is shared among all municipal partners and the unincorporated territories on a total assessment bases. The local municipal assessment by community is divided by the total municipal assessment of the entire KDSB iurisdiction. Dan indicated that in comparison the City is getting good value for its money of services received. The 2014 municipal levy for Kenora is \$3.1 million of the total \$15.4 million to be collected in municipal levies by KDSB to help fund the four core services offered in the region. It was indicated that there was an increase of \$191,000 more than 2013 for total municipal levy to the services board to account for embedded and planned costs. KDSB's total budget information was provided for 2014 to indicate how the costs are shared, showing local versus provincial costs. Public housing is the biggest cost for municipalities as it is funded one hundred percent by local share. It was noted that homelessness and shelter issues are common in Kenora and on ongoing concern.

Key statistics for 2013 were provided for each service offered by KDSB. A breakdown in Ontario Works cases shows there were 647 cases in the region with 252 of those cases managed in Kenora. There are 1,111 social housing units of which 463 are located in Kenora. The Land Ambulance program responded to 10,682 calls for emergency medical services, including approximately 3,000 non-emergent patient transfers, of which 3,675 originated in Kenora. There were 718 Child Care subsidies paid in total and 265 of those were distributed in Kenora.

Dan elaborated on each service offered by the KDSB and indicated that these core services are being provided as mandated. Areas for improvement and cost savings were explained. On the matter of non-emergent land ambulance patient transfers, the services board will continue to lobby the province to assume the cost of transporting patients between hospitals. The KDSB has also adopted a 10 Year Housing and Homelessness Plan, which identified a need for more affordable housing in most of the communities. The services board is looking at reducing the number of social housing units in locations where they remain vacant and building more units in the areas where they are in demand. A specified number of housing units are mandated by the province and there are high maintenance costs associated with the unused units.

Moving forward, the KDSB is awaiting Ministry of Municipal Affairs and Housing response to their 10 Year Housing and Homelessness Plan and are engaging into a process for their next five year strategic plan as 2014 will end the current plan. It was noted that the KDSB and City will work together to lobby the provincial government for funding to assist with social housing concerns. The plan is to seek further partnerships with other public organizations in Kenora to ensure that all have the same goal. It was recognized that Ontario is the only province where social services have been downloaded to municipalities.

Dan was thanked by Mayor and Council for his presentation.

Regarding the numerous water main breaks this winter, Councillor Roussin posed the question to Operations Manager, Rick Perchuk, if the City is doing an adequate job replacing these mains as they occur to establish a more viable water system and that future breaks do not happen in the same areas. Mr. Perchuk advised that the City is not replacing them adequately as they are only able to work within the budget allocated to them annually for replacement. The 10% annual water and sewer rate increase should help address these regular shortfalls in replacement and the asset management plan identifies the problems with replacement costs as well.
