Once the Kenora Urban Trials Committee has agreed upon the Great Lake of the Woods Trail route, request for designation of the trail will be sent to City Council.



GIS Presentation

Bimal Adhikari, City of Kenora GIS Technologist was invited to the May 5th, 2015 meeting to present the Kenora trail network in the GIS to the committee. The purpose of his presentation was to confirm that the trails information within the maps is correct, prior to making the map public on the Kenora.ca website.

Attached is a PDF version of the presentation; committee members who were not preset at the meeting will not be able to access the GIS to see the interactive map. Below are screen shots from the presentation for a general idea.



The Committee noted that the following trails were missing:

- 1. Laurenson's Creek
- 2. Rotary Way

The Committee asked Bimal to review the Lake of the Woods Trail Guide and to include on the GIS, the descriptions of the trails as found within the trail guide. Information to include: Distance, Terrain, Seasons, uses etc.

Tunnel Island, although considered common ground, will require approval to publish this network of trails on the GIS.

Bimal also presented a network of Biking trails; there was confusion as to the difference between commuter and recreational routes, and if they need to be colour coded. A meeting is to be set up with David Schwartz and Bimal to further discus the mapping of these routes.
