**Lot "O": Kenora Recreation Centre Long Term Parking**  
**Control: Recreation Centre Manager and Peace Officer**  
**Fees: Over night \$7.00 plus GST**  
**Weekly (7 day) \$35.00 plus GST**  
**Monthly (30 day) \$130.00 plus GST**  
**(No refunds for unused parking)**
