A. PUBLIC INFORMATION NOTICES AS PER BY-LAW NUMBER 14-2003

C. CONFIRMATION OF MINUTES

D. REPORTS:-

1. Wage Increase – Contracted Fitness Instructors RECOMMENDATION:

THAT Council of the City of Kenora receive the recommendation from the Leisure Services Committee to authorize the increase the implementation of the contracted fitness instructors wage to \$20.00 per hour, effective immediately.

2. Community Club Grants

RECOMMENDATION:

THAT Council of the City of Kenora receive the recommendation from the Leisure Services Committee approving the grant amount of \$4,000.00 to Central, Rideout and Evergreen Community Clubs.

It was noted that financial statements have been received by the Leisure Services Committee for these Clubs, however Pinecrest has not yet forwarded their grant request.

Councillor Cuthbert expressed her concern that the operation of the facilities should not be at the expense of the Clubs, and it was noted this is something Council could discuss during the budget process.

3. Jack Pine Budworm Infestation – Kenora Urban Forest (Information Report)

Barb Manson attended and advised this item should continue to be monitored but that no further action is needed at this time. She explained there are two ways to control this problem either naturally or with the use of a chemical (BTK) which does not affect humans or nature, and is environmentally friendly. MNR is currently using the chemical on Crown Lands however Barb sees no reason to use this in the urban forest.

4. Post Secondary Student Rate RECOMMENDATION:

THAT Council of the City of Kenora receive the recommendation from the Leisure Services Committee, approving the rate of \$140.00 for a post secondary student's membership rate at the Kenora Recreation Centre; and

THAT Council give three readings to a by-law to amend Schedule "B" to Tariff of Fees and Charges By-law Number 100-2003; and further

THAT the new rates take effect immediately upon third and final reading of the by-law.
