## AGREEMENT WITH ABITIBI CONSOLIDATED INC – ACCEPTANCE OF MUD LAKE LANDFILL LEACHATE AT SEWAGE TREATMENT PLANT.

- The City's Comprehensive Bylaw Review requires updating of Bylaws adopted pre amalgamation.
- The Town of Kenora entered into an Agreement with Boise Cascade Canada Ltd., now Abitibi Consolidated Inc., in 1993 to accept Leachate from the Mud Lake Landfill Site to the Municipal sewage system.
- The term of the original Agreement was 30 years. The new updated Agreement will be for 20 years.
- It is recommended that the Agreement be updated to reflect a name change to "City of Kenora", "Abitibi Consolidated Inc., and the remaining term left Jan. 1 2005 to Jan. 1 2025.
