1. Agreement – Municipal Source Protection Pre-Screening Project RECOMMENDATION:

2. Grinder Pump Maintenance RECOMMENDATION:

THAT the City of Kenora provide the option to homeowners a fee for service for maintenance of grinder pumps on private property.

Discussion:

Councillor Poirier proposed, for discussion, the option of operating grinder pumps similar to an agreement used for hot water tank rentals. A monthly fee would be paid and a reserve fund set up to finance monthly maintenance and replacement costs for grinder pumps. Currently, residents do not know what to do when their pumps fail. They can't get private contractors or City staff to assist them due to confusion surrounding area of responsibility. Councillor Compton commented that some homeowners are threatening legal action, but doesn't feel the City is in a position to take over the overall maintenance of homeowner grinder pumps. He is in agreement with charging a monthly fee and building up a reserve fund to be drawn from. The monthly fee could be determined by establishing a replacement and maintenance operating cost. Mayor Canfield suggests item remain on hold until further information is gathered on cost. He cautioned that there will be a need for established policy and procedures to ensure homeowners practice proper pump maintenance. Committee agreed with Bill's suggestion to bring back the options presented in a previous report, with the addition of the above option, for further discussion.
