<u>Pam & Warren Cederwall and Mabel Spencer – 19th Avenue North</u> Snowmobile Corridor

Mrs. Cederwall appeared before Committee and presented a report detailing how the noise and excessive speed created by snowmobile traffic using the 19th Avenue North snowmobile corridor is disturbing the health and safety of her family. Mrs. Spencer stated that snowmobiles are using the corridor after 11:00 p.m. They collectively request the corridor be moved to a non residential area.

<u>Pam & Warren Cederwall – Request Property Access Off 19th</u> Avenue North
